What is the New Participant Portal?



Starting on July 1, you can log on to www.scibew-neca.org and click the **REGISTER FOR NEW PARTICIPANT PORTAL** button to enroll for the new Participant Portal experience. You will now have access to the new look, user-friendly resource that will offer you everything you need to know about your Health and Pension benefits and reported hours.

The new portal provides you with access to the most current information available.



- Access and view personal demographic information including current address and phone number on file.
- Access and view eligible dependents enrolled in the Southern California IBEW-NECA Health Plan.



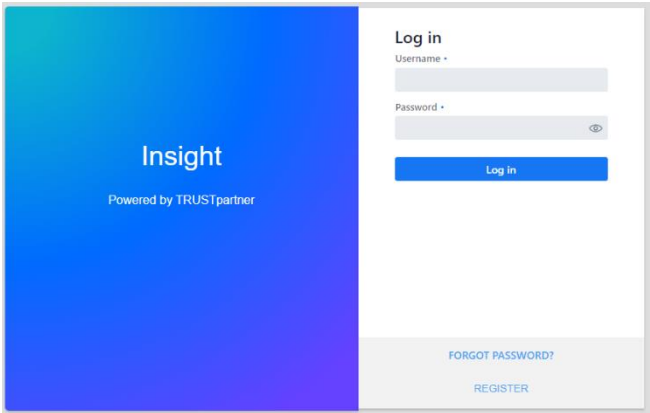
- **NEW!** Access and view real-time Southern California IBEW-NECA Active Health eligibility and hours bank reserve.
- **NEW!** Access and view your Southern California IBEW-NECA Pension Estimate Summary.**
- Access and view your Southern California IBEW-NECA Active Health enrolled benefits.



- **NEW!** Access and view your up-to-date work history of reported hours. Up-To-Date work history tab will include Work Period, Employer Name, Account Number, Working Local, Job Class, Reported Hours and Reported Wages.

**This estimate is subject to verification of covered employment at the time an application for pension benefits is submitted. In all cases, the rules of the relevant Plan documents will govern. The Administrative Trust Funds Office cannot provide your actual benefit amount until you apply for benefits. That amount may differ from the estimate because your hours worked may increase or decrease in the future. What do you need to do?



Be sure to log on, tune in and get connected. Visit www.scibew-neca.org and click the REGISTER FOR NEW PARTICIPANT PORTAL button.

1. You will be redirected to the NEW Participant Portal. You will click the blue REGISTER button to enroll in the new and improved Participant Portal.

2. All Participants will need to register as a “new user”.* Enter your last name on file, birth date in the xx/xx/xxxx format, full Social Security Number and your e-mail address, then click “continue registration”.

*This step is required from all participants, even if you had an account through the previous portal.

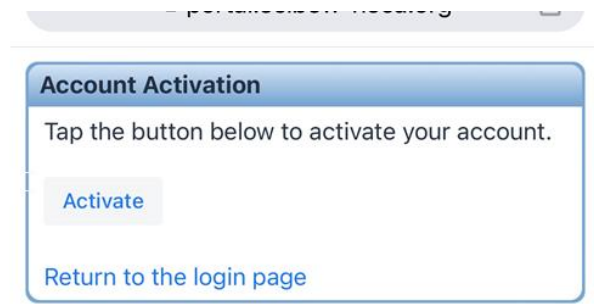
3. Select a Username. Your username should be the e-mail address used in the registration page. Create a unique password. Use a combination of at least 8 letters, numbers and symbols. Then click “REGISTER”. You will receive a confirmation message below:

4. You will receive a confirmation e-mail to complete your registration process. You MUST complete the registration process by following instructions sent to the e-mail you provided.

5. To the left is a sample confirmation e-mail and request to activate the new account. YOU MUST COMPLETE REGISTRATION WITHIN 12 HOURS OR THE LINK WILL EXPIRE.



6. The link in your e-mail will provide the screen to the left. Select to Activate the account. Once process is completed, return to login page. You may login with username and password provided through the registration process. Success! You are now registered for the NEW Participant Portal!
